What is Your Plan?



By 2030, it is estimated that there will be more than 75 million Americans that are 65 years old and older. That means that 10,000 people a day will be turning 65 years old. 70% of adults 65 years old and older will one day need assistance. With the large amount of Baby Boomers, it is estimated that over 52 million Baby Boomers will one day need assistance. Not only is the increase of aging adults a concern when considering planning ahead, but the pricing of these facilities can also be a concern. Assisted Living on average costs \$4,300 per month and memory care on average costs \$5,375 per month. When the unexpected happens, financial stress can strain loved ones and give them overwhelming feelings while they help care for the future.

As an adult child, we need to still respect, love, and understand our parents as they go through another life transition. This is not only difficult for adult children, but it is also difficult for their parents. However, to properly prepare for the future, it's important to understand your parents' finances, know their plan and know where their legal documents are. When having these conversations, you must consider if it is safe for your parents to live at home and if you can handle the responsibility of a caregiver on your own.

A report from the American Seniors Housing Association (ASHA) is helping us answer questions about the Boomers, such as their lifestyle and what they want in the future. The report shows the kind of amenities, services, and location that Boomers are looking at. It also helps us know the demographics, psychographics, behaviors, and geographic locations Boomers are in. The report is based on surveys completed by 7,000 people, of which 80% were Boomers.

Who the Boomers Are

- One third of the respondents live in a house with another person
- The average respondent has 2.5 children; 22% of respondents have no children
- The average respondent has 4.8 grandchildren; 37% of respondents have no grandchildren
- Two-thirds of respondents live in the suburbs; 23% live in rural areas; 11% live in urban areas
- 43% prefer to move to outlying suburban areas; 23% to close-in suburbs; 19% to small towns; 7% for both urban and rural areas
- Nearly 60% are considering transitioning to a senior living community within the next four years
- 69% will include senior housing communities in their search when considering a move; 31% prefers to live in senior housing
- Among residents who were like to move into senior housing, 27% said they would move up to 15 miles from their current homes; 32% said they'll move up 15 to 40 miles; 30%

said they would move between 40 and 999 miles away; and 11% said they would move up to 1,000 miles away or more

What the Boomers are Looking For

Boomers value their independence and their ability to rely on themselves. They also value their ability to socialize and enjoy themselves, so amenities are extremely important to the Boomers. This generation also became more tech savvy from the Covid-19 pandemic, so smart features are also important, such as remote lighting, heat, appliances and security systems. When entering this stage of their life, they want more time to enjoy themselves, meaning that the daily tasks that they are usually completing are wanted to go away, such as lawn care, 24-hour security and maintenance. Some do not want help with ADLs, such as bathing, dressing or managing medications, but if they can no longer take care of themselves in the future then they are openminded for help with those tasks.

Luckily, when staying at McGregor, Boomers have access to many amenities, such as outdoor patios, Tootie's Cafe, the library, dining rooms and walking trails. McGregor also has many activities throughout the weeks, which allows for that socialization that Boomers are looking for.
